



**APPLICATION FOR NH FISH & GAME DEPARTMENT TEMPORARY LICENSE 12/10**  
**ACTIVE DUTY ARMED FORCES AND COAST GUARD. RSA 214:3 Fis 1101.06**

**FREE**

When applying for a Temporary license for active duty armed forces and coast guard, the following are requirements:

1. Residents of N.H. stationed OUTSIDE of New Hampshire are eligible for this license, must present duty orders for proof – NH must be your home of record.
2. If you are requesting a hunting license you will need proof of hunting, we require a previously held hunting license from any state, province of Canada or country. Or a Hunter Safety Certificate from any State Authorized Hunter Education Program.
3. The license issued is temporary, only valid as long as you are active duty, a New Hampshire resident stationed outside of N.H and to be used while you are on leave. Note: If end date for effective dates for active duty is "Indefinite" license will expire 1 year from issue date (would need to reapply each year) or when active duty criteria is no longer met.
