## APPLICATION FOR APPRENTICE HUNTING LICENSE

RSA 214:6-a

**A person holding a N.H. Apprentice Hunting License shall be allowed to hunt only when accompanied\* by a properly licensed person who is 18 years of age or older.** The properly licensed person who is 18 years of age or older accompanying the apprentice shall be fully accountable for any damage incurred or for any violations which may be committed by the apprentice while hunting.

**An Apprentice Hunting License may be purchased only once in the lifetime of the hunter.** A N.H. Apprentice Hunting License is good for one calendar year only. To hunt in a future year, you must complete a hunter education or bowhunter education course, then buy a regular New Hampshire hunting license.

**The N.H. Apprentice Hunting License shall not be valid to take moose** and shall not apply to the 3-day Nonresident Small Game License.

\*Definition of Accompanied: When accompanied: within sight and hearing, excluding electronic devices, when actual physical direction and control can be effected.
